Yippee - We've Got a Place to Stay!

A new era for shipmates of the USS Allen M. Sumner will begin next year as they join with sailors of the USS Moale in a joint reunion in Nashville, Tenn.

The event is to be held in the Best Western Plus Nashville downtown hotel May 3 to May 6, 2020 at a room rate of \$125.90 per night

The hotel is located at 2401 Brick Church Pike, Nashville, Tenn. 37207

Initially 40 rooms have been blocked and the same room rates will be applicable 3 days before the arrival of the group and 3 days after the

departure of the group.

The Sumner will be allowed to get food and alcohol from outside.

The hotel shall only provide tables and chairs. Everything else will be provided by us. The hotel shall provide the ice to us in the coolers that will be supplied by us.

The hotel includes event space, Complimentary Hot Breakfast Buffet, an Outdoor Pool, a Gym

along with Free Wi-Fi, a Business Center, an Indoor Market as well as a Free Downtown Shuttle (2.5 miles).

Other sites include the Johnny Cash Museum - 3.8 miles and Music City Center - 4.1 miles.

I'll tell you what's hard. It's being a graduate of a university in the same conference playing a football team other than your own when that team happens to be Navy.

And to make matters worse, for years my wife and a nephew have had moderately expensive season tickets except for this year when we decided to get general admission (much cheaper) in part due to several crummy seasons.

Interesting enough our coach has never won against Navy in the four since he as hired.

The general admission seats are also where the visitors sit.

I decided to compromise for this game - wear my school colors and my Sumner hat.

On the first play of the game, Navy provided us with a gift - a fumble on their own, 20-yard line.

But alas, we couldn't take of it and our place kicker muffed a three-point attempt.

We were pretty much used to this as our team lost the previous week to Southern Methodist

University in three overtimes - each the result of a bad field goal attempt.

The rest of the game (our fans would call it a debacle) was pretty much a runaway for the Midshipmen.

There were two bright spots in the game - at halftime a rear admiral swore in 50 new recruits and I was sitting behind a lad wearing a ball cap denoting the plank owner of the USS Robert

K. Huntington (DD-781) - an Allen M. Sumner class destroyer.

I engaged him in conversation and the cap turned out to have belonged to his grandfather.

I told him his grandfather's ship was in my ship's class and he then noticed my hat and made the connection.

The Huntington was one of the ships which escorted battleship Missouri into Tokyo Bay to receive the official Japanese surrender. She then returned to San Diego carrying 100 marines home.

There were other similarities between the Sumner and Huntington: In the spring of 1946 she returned to the Marshalls as a unit of JTF 1 during Operation "Crossroads" the first atomic bomb test at Bikini.

In July she witnessed the air burst from a considerable distance and the more spectacular underwater blast from the comparatively close range of 10 miles.

Veterans Day Services Held for Plank Owner

A funeral service was held on Veterans Day at Tuscaloosa Memorial Park and Chapel for Clarence McKinley Clements, 95, of Midfield, Ala. who died on Nov. 6, 2019 at Veterans Hospital, Birmingham. A military burial followed the chapel service.

Clarence was born Sept. 30, 1924 in Henry County, Ala. He spent his younger years living in Tuscaloosa, before moving to his current home in Midfield.

Clarence was a proud World War II Navy veteran who served on the USS Allen M. Sumner. He escorted the USS Missouri to the signing of the Peace Treaty, served in major battles in the liberation of the Philippines, and was awarded a Presidential Citation for his service.

At a recent ship reunion, he was recognized as a "plank owner" of the USS Allen M. Sumner meaning he was on the ship when it was being built. In 2009 Clarence attended an Honor Flight to Washington, D.C.

Clarence worked for Buffalo Rock Bottling Company in Tuscaloosa before he moved to Midfield and worked as a heavy equipment operator. Later he worked for Jack Cole trucking company where he retired.

He was a master mason of the Pleasant Grove Masonic Lodge, No. 909.

He read his "Birmingham News" every afternoon until Judge Judy came on TV. He stayed up too late watching old Westerns. He was determined to remain independent, was a generous man, a big fan of Alabama football, and he loved listening to old Gospel music.

He is survived by his grandchildren Jeffrey Kyle Grayson (Jennifer), Shaun Chadwick Grayson "Chad", Jason McKinley Clements (Theresa) and Jennifer Raye Clements. Clarence is also survived by eight great grandchildren, many nieces and nephews, and caring next door neighbors.

The family suggests memorials to made to favorite charities in lieu of flowers.
